ENTRY REQUIREMENTS

Applicants with an education of the appropriate level, confirmed by a document on secondary general education or a document on vocational secondary education and qualifications, or a document on higher professional education, confirmed by the assignment of the qualification are allowed to master the educational program.

PROGRAM STRUCTURE

General subjects include: Foreign language, History of medicine, Law, Biology, Human Anatomy - Head and neck anatomy, Latin and Philosophy. The most voluminous disciplines of a viewing nature - Human anatomy - Head and neck anatomy, Histology, Embryology, Cytology-histology of the oral cavity, Biology - are spread over two semesters.

The main types of learning activities are lectures and practical classes. The scope of the specialty program and its blocks in credits:

Block 1 Disciplines (modules) - at least 270

Block 2 Practical training - no less than 24

Block 3 State final attestation - 3.

The specialisation is divided into a compulsory part and a part formed by the participants of the educational relations.

In accordance with the FSES of Higher Education, the volume of the compulsory part excluding the volume of the state final attestation is not less than 80% of the total volume of the specialisation programme.

Block 2 Practicum includes both practical training and work placements.

The programme provides students with the opportunity to study elective disciplines (modules) and elective disciplines (modules).

Elective disciplines (modules) are not included in the scope of the degree programme.

Block 3 "State Final Attestation" includes preparation for and passing the state examination.
